Pursuant to Sec 37-2-41(a), each transportation company, as defined in Sec. 37-2-1, doing business in Alabama and subject to the jurisdiction of the Public Service Commission with respect to its rates and service regulations shall pay quarterly to PSC, beginning each November 1 and on each quarter thereafter, February 1, May 1, August 1, of each year, a fee for the inspection and supervision of such business during the next preceding fiscal year. Any transportation company may, at their own election under Sec. 37-2-41(d), pay over the total fees due for the preceding fiscal year on November 1 of each year. Transportation companies with more than \$60,000,000 of Alabama gross receipts in a calendar quarter must pay quarterly based on gross receipts for the calendar quarter ending March 31 (by Nov. 1), June 30 (by Feb. 1), September 30 (by May 1), and December 31 (by Aug. 1).
