ORDER

BY THE COMMISSION:

By filing received April 15, 1986, with a requested effective date of April 23, 1986, Petitioner South Central Bell petitioned this Commission for approval of revisions to its existing telephone tariff as set out herein:

These proposed tariff revisions introduce Shared Tenant Service offerings which is a shared service arrangement allowing business basic measured local exchange service to be resold. It grandfathers the currently approved Joint User

Service offering. The regulation on limitations and use of service is being extended to include the resale environment. This filing also changes Directory Listings regulations to accommodate the resale environment. The definition of "Premises" is redefined in connection with resale of basic local exchange service.

Petitioner originally filed revised tariffs to introduce provisions for Shared Tenant Service on August 21, 1985, with a requested effective date of October 23, 1985.

By order, dated September 9, 1985, the request was suspended for six months from the requested effective date to and through April 10, 1986. The Commission also established Docket 19576 for the purpose of establishing rules, regulations and guidelines governing the provision of Shared Tenant Service, and consolidated Docket 19576 with Docket 19512. Following notice, public hearings began on December 16, 1985.

By order dated April 8, 1986, the Commission approved the provision of Shared Tenant Service offering the resale of local exchange service, denied the proposed tariffs filed by the Company on August 21, 1985, and ordered that Petitioner file within thirty (30) days, subject to Commission approval, a tariff providing for Shared Tenant Service offerings pursuant to the findings of the Commission, with a proper effective date.

By filing on May 2, 1986, Petitioner amended the April 15, 1986, filing to correct page references and numbering errors as follows:

- Contents - 15th Revised Index Page 6; change references from Pages 266, 167 and 168 to Pages 171, 170 and 171 respectively
- Section A3 - 2nd Revised Page 25; change footnote reference from Page 167 to Page 170

 - 6th Revised Page 26; change footnote references from Pages 169 and 170 to 172 and 173 respectively
- Section A100 - 13th Revised Page 2.2; change reference from Page 167 to 170
 - Original Pages 167 - 170; change to Original Pages 170 - 173 respectively

The Commission is now of the opinion, and finds, that the public interest will be served by approval of these tariff revisions, and that such revisions are in compliance with the April 8, 1986, order.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That Petitioner South Central Bell's proposed tariff revisions, as set out herein, hereby be approved.




IT IS FURTHER ORDERED BY THE COMMISSION, That this order shall be effective as of the Company's requested effective date of April 23, 1986.


