Petitioner petitions the Commission for an Order declaring the minimum amount of security required of Petitioner to compensate shippers and consignees for loss of or damage to their property coming into Petitioner's possession in connection with Petitioner's transportation service to be \$1,000.00; and

Petitioner further petitions the Commission for an Order approving Petitioner's qualifications as a self-insurer as to cargo insurance.

As justification for said Order, Petitioner represents and shows to the Commission:

1. The maximum value of any cargo Petitioner ordinarily and regularly carries is not more than \$1,000.00;
2. The attached financial statement of the Petitioner is true and correct, and shows net assets of more than \$5,000.00;
3. The assets shown on the attached financial statement are available to pay any final judgment rendered against Petitioner for loss of or damage to property belonging to shippers and consignees and coming into Petitioner's possession in connection with Petitioner's transportation service; and
4. Petitioner will notify the Commission if the value of its net assets diminishes by 10 percent or more.
